

Try2Help's purpose

Try2Help's (T2H) is a fledgling organization arising from a perceived need to show financial fidelity to all doners. T2H will have NO paid upper management types, have open books, will post to our website (www.Try2Help.charity) purchase receipts, and be open to all forms of accountability.

COSTCO's Warehouse Donation Request Form has the question: "*How will a Costco donation assist your program?*" To elaborate on T2H's response. T2H spends about \$300 to \$450 per week purchasing food, and other necessities (shoes, coats and hygiene items seems to be a constant need) for the Homeless community. T2H's services are totally dependent on donations, which are very irregular, thus difficult to maintain T2H's stability of services. So, gaining some corporate commitments (hopefully like COSCTCO) would be a great aid the stability of the mission's effort. A weekly or monthly donation would be great, perhaps an allowance on a Costco Card. The need is unlimited, as no matter how much we try there is always more that can be done, our current goal is to provide services everyday (currently T2H feeds (50-75 persons) three times per week)

In T2H bylaws it states:

ARTICLE 2 - PURPOSE

The general purposes for which this Ministry, T2H, has been established are as follows:

The general purpose for which the Non-Profit out-reach Ministry, T2H, is formed is set forth in the attached Bylaws and Articles of Incorporation [neither attached to this document] of the Hosting Corporation/Organization [San Antonio Baruch Hashem Congregation].

The Hosting Corporation/Organization is/has been established [in 1992] within the meaning of IRS Publication 557 Section 501(c)(3) Organization of the Internal Revenue Code of 1986, as amended (the "Code") or the corresponding section of any future federal tax code. The Corporation/ Organization's outreach ministry T2H shall be operated exclusively to create the expectations for followers (Mathew 25:35) of Jesus Christ to physically demonstrate our love for our fellow man (neighbors).

Therefore, T2H is one such effort of the members of the body of Jesus the Christ (Christians) to cooperatively accomplish this goal.

In addition, this out-reach ministry (T2H) of the Hosting Corporation/Organization has been formed for the purpose of performing all things incidental to, or appropriate in, the foregoing specific and primary purposes. However, the Hosting Corporation/Organization and this out-reach ministry shall not, except to an insubstantial degree, engage in any activity or the exercise of any powers which are not in furtherance of its primary non-profit purposes.

The Hosting Corporation/Organization and this out-reach ministry shall hold and may exercise all such powers as may be conferred upon any nonprofit organization by the laws of the State of Texas and as may be necessary or expedient for the administration of the affairs and attainment of the purposes of the Hosting Corporation/Organization and this out-reach ministry. At no time and in no event shall the Hosting Corporation/Organization and this out-reach ministry participate in any activities which have not been permitted to be carried out by a Corporation/Organization exempt under Section 501(c) of the Internal Revenue Code of 1986 (the "Code"), such as certain political and legislative activities.
